## [About Ken Corporation Ltd.]

Ken Corporation Ltd. was founded in 1972 and, as a pioneer in the luxury real estate business, started a luxury rental brokerage business for executives such as employees and managers of foreign companies. Currently, we offer a full range of real estate-related services, from rental brokerage for homes and offices, to sales brokerage, management and operation of homes and buildings, development of large commercial facilities and hotels, and urban development such as redevelopment of areas.

In addition to real estate, we have formed the Ken Corporation Group, which consists of 81 affiliated companies and approximately 7,800 employees, and are involved in hotel business, solar power generation business, entertainment and other cultural business.

In the hotel business, after working on joint hotel development in the mainland United States in the 1980s, we began full-scale operations in 2000. Currently, we own a total of 37 hotels and inns with approximately 9,500 rooms, including 28 hotels and inns in Japan and 9 hotels overseas under our own brand and top foreign brands, which are operated and developed by Ken Hotel & Resort Holdings Co., Ltd. In the cultural business, group company Shibuya Television Co., Ltd. operates the live music venue "Shibuya O-Group" and large street vision screens as part of its music entertainment business, while K Arena Management Co., Ltd. manages and operates one of the world's largest music arenas, "K Arena Yokohama."
